Decarbonization strategy takes shape in Gujarat Rajkot man suspects wife in porn video, attacks her with needle



AHMEDABAD: In line with the Union government's drive to curb carbon emissions, the Gujarat government has begun formulating a comprehensive policy for decarbonization in the state. This policy is anticipated to be introduced as early as November to coincide with India's presidency of the G20.

Various departments have been tasked with contributing their insights on actionable decarbonization targets. According to reliable sources,

high-ranking officials from crucial departments will present a decarbonization policy draft to government decision-makers.

The sources added that the upcoming decarbonization policy will align with the Union government's decarbonization guidelines and reflect India's commitment to carbon reduction on the global stage.

Inputs have been sought from various departments, including industries and mines, agriculture, climate

change, environment and forest, as well as energy and petrochemicals. The collaborative effort aims to identify measures that can effectively mitigate carbon emissions.

The industry and energy sectors are expected to contribute vital insights due to their significant reliance on conventional fuels said sources, adding that the policy's primary focus will be on augmenting renewable energy generation and facilitating industrial transition from fossil fuels to renewable alternatives.

Incentives are also being considered to motivate industries to transition towards renewable energy sources for their operations.

Earlier this June, on World Environment Day, the state government announced its target to curtail carbon emissions from energy production to 139 million

tonnes by 2030. This ambition will be pursued by augmenting the installed capacity of renewable energy to 68,000MW in the next eight years. Highlighting its progress, the government reported a noteworthy reduction of around 11% in carbon emissions in 2022 compared to 2017, attributed primarily to the increased integration of renewable energy sources in power generation. This policy is anticipated to be introduced as early as November to coincide with India's presidency of the G20. RAJKOT: Suspecting that the woman in the porn video he was watching was his wife

with her boyfriend, a 51-year-old man in Rajkot wounded his wife with a large needle that's used for stitching a jute bag on Tuesday night.

Geeta Bhupkar (45), in her complaint, said that she and her daughter Anushree (24), who came to save her from her husband Haresh Bhupkar, suffered injuries.

The University police station, after receiving a complaint from Geeta, arrested her husband on Wednesday under IPC Section 324 (assault). Geeta and her daughter both were admitted to Rajkot civil hospital for treatment.

The woman is a mother of two - a 24-year-old daughter and an 18-year-old son. According to Geeta's complaint, her husband Haresh, who is a marketing professional, got addicted to porn after he purchased a new mobile.

Earlier too, Geeta's husband had accused her of performing in the porn videos with her boyfriend and had fights with her.

The woman had approached police last week with a complaint but before registering the FIR, the family settled the issue.

However, on Tuesday

night, when Geeta was sleeping, Haresh suddenly approached her and attacked her with the large needle used to stitch jute grain bags.

As she started screaming, her daughter Anushree came to save her but Haresh also attacked and injured her. According to the police, Geeta received injuries on the abdomen, both her arms and one leg, while her daughter received injuries on the hand. Budhau purn dekh raha tha. 1-kg heroin packet recovered from Jakhau coast

Ahmedabad: The Border Security Force (BSF) on Wednesday said that they have recovered a packet of heroin weighing a kilogram, which washed ashore near Siyari Creek off Jakhau coast in Kutch. "On August 23, in a special joint search operation, BSF along with Marine Police, Jakhau recovered one packet of heroin, weighing approximately 1 kg from Siyari Creek about 1 km off Jakhau coast," BSF said a statement. BSF has launched an

extensive search of the isolated bets off Jakhau coast in Kutch after the recovery of the drugs. The statement adds, "Since mid-April 2023, BSF recovered 91 packets of Charas and 11 packets of Heroin off Jakhau coast." Recovery of drug packets has been constantly reported off Gujarat coast as the state is used as a destination for the transit of drugs. "The packet found near Siyari Creek might have been dropped from a ship or boat carrying a huge

stock of drugs," said a BSF officer. Earlier in May, BSF had recovered three packets of heroin from an isolated island near Jakhau. The packets weighing 1 kg each were found on the shore at Lunda Bet, about 12 km from Jakhau. Apart from Charas and heroin packets, BSF also recovered two packets of amphetamine since mid-April. In July 2020, eight packets containing 5.8kg of charas were discovered near Jakhau by a preventive team of Kandla Customs.
