WESTERN RAILWAY CROSSED Rs. 100 CRORE MARK IN SCRAP SALE DURING CURRENT FINANCIAL YEAR

Ahmedabad, Western Railway is committed to make all its railway establishments and units, scrap free under the "Mission Zero Scrap". Under the dynamic leadership &

by scrap sale. According to a press release issued by Shri Sumit Thakur - Chief Public Relations Officer of Western Railway, it is worthwhile to mention that despite the uncertain and difficult time of COVID-19 pandemic, Western Railway not only achieved the onerous task of scrap sale target of Rs. 410 crores in the financial year 2020-21, but also surpassed it by a substantial margin of 20%. Western Railway sold scrap worth Rs. 491.04 crores in 2020-21, making it highest amongst all Zonal Railways & Production Units of Indian Railways.

Shri Thakur added that in the past three years, Western Railway has been consistently selling scrap of approx. Rs 500 crores which has helped in monetization of blocked funds and consequent revenue generation. Continuing with its march of Mission Zero Scrap, Western Railway became the first Railway to cross first milestone of Rs.100 Crs on 30th July, 2021 by selling scrap worth Rs.102.32 crores till 30th of July 2021. Under the directives of General Manager Shri Kansal and Principal Chief Materials Manager Shri D. K. Shrivastava, Western Railway has set its target to make the Zonal Railway completely scrap free & aims to achieve 100% scrap free status at all its workplaces by the end of current year.

Veraval add collector's car hits motorcycle, one killed



Rajkot: One person was killed while the other sustained serious injuries as the motorcycle they were riding was hit by the official car of Veraval additional collector on Saturday night in Veraval town of Gir-Somnath district. Sources said that the additional collector's driver was driving the car at the time of the accident. According to Prabhas-Patan police, the deceased was identified as Harendra Yadav (35), a native of Bihar state. The injured person was identified as Simar village on motorcycle and the speeding car hit him near the entrance gate of Veraval town. Such was the impact of the collision that Harendra died on the spot.

Ravindra Yadav (38), elder brother of Harendra, who lives in Vasanel village, lodged a complaint against the

car driver with police station. Police have detained the car driver and a probe has been launched.

45,847 register for admission in MSU

Ahmedabad : MS University has extended the last date of registration for admission in major programmes offered by it. The university has extended the last date of registration till August 13 to avoid last minute rush from aspirants seeking admission in various courses. Even as results of class 12 science and general streams have been declared only recently by the Gujarat Secondary and Higher Secondary Education Board and the Central Board of Secondary Education, the university has already received 45,847 registrations from students seeking admission in various programmes. Out of 45,847 registrations, 35,408 students have completed the application process. But in view of the record high pass percentage in science and general stream, the university is

expecting more students to apply for admission in conventional courses. So far, the university's largest faculty in terms of student strength — the Faculty

of Commerce — has received 13,204 applications followed by the Faculty of Science where 10,652 students have submitted applications.
